1. MOONWALK(S) &/OR EQUIPMENT(S), RENT AND TERM RENTAL AGREEMENT: The undersigned, as Lessee (customer), hires from MJ MOONWALKS & Party Rental, as Lessor (company),

_____ Moonwalk(s) &/or Equipment(s) unit, identification number or name of Moonwalk(s) &/or Equipment(s):

The Rental Fee as stated above is payable ½ to hold the moonwalk for your event with rest of Rental Fee to be paid in full two weeks in advance from the time of commencement. Cleaning fee of \$50.00 in CASH will be return if moonwalk unit is clean went MJ MOONWALK picks up the unit.

2. DELIVERY: The moonwalk(s) &/or equipment(s) will be delivered to the street address specified above by Lessee (customer). Lessee grants MJ Moonwalks & Party Rental the right to enter the property at the said street address (“Delivery Address”) for the delivery and subsequent pick up of the moonwalk(s) &/or equipment(s) at the specified time.

3. TRANSPORTATION EXPENSE: MJ Moonwalks & Party Rental includes delivery and subsequent pick up of the moonwalk(s) &/or equipment(s) with respect to the delivery address are included in the rental within 30 miles of the business. An extra fee will be charges if over 30 miles at a fee of \$2.00 per miles. We do not deliver if destination is over 40 miles from the zip 51503. In the event that the moonwalk(s) &/or equipment(s) is not timely surrendered by lessee (customer) to lessor (company) then a \$50.00 extra transportation fee shall be automatically imposed.

4. GENERAL RULES TO FOLLOW DURING USE OF THE MOONWALK(S):

A. ONLY COMPATIBLE AGE GROUPS AND SIZE SHALL PLAY ON THE MOONWALK(S) AT THE SAME TIME. THE MAXIMUM NUMBER OF RIDERS OF EACH GROUP THAT SHOULD PLAY IN THE MOONWALK(S) AT ONE TIME IS (Not to excess 350 lbs max)

B. ALL RIDERS MUST REMOVE SHOES BEFORE PLAYING IN THE MOONWALK(S) UNIT.

C. TO AVOID NECK OR BACK INJURIES, FLIPS ARE NOT ALLOWED.

D. TO PREVENT MOONWALK(S) FROM BLOWING OVER. TAKE DOWN IN WINDS EXCEDING 15 MPH.

E. CHILDREN’S SAFETY DEPENDS UPON YOU. ADULT SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE MOONWALK(S) UNIT, THE SAFETY OF ALL RIDERS IS YOUR RESPONSIBILITY.

F. ABSOLUTRLY NO “SILLY STRING”, GUM, CANDY, FOOD, OTHER STICKY SUBSTANCES, SHARP OBJECTS & ETC. ARE ALLOWED IN THE MOONWALK(S) UNIT. IF, UPON PICK UP, SUCH CLEANING IS REQUIRED THEN YOUR \$50.00 CLEANING FEE DEPOSIT WILL NOT BE REFUNDED. BY INITIALING LESSEE (customer) AGREES TO THIS PROVISION. BY INITIALING TO THE LEFT, THE LESSEE AGREES TO THIS PROVISION.

G. DO NOT MOVE THE MOONWALK UNIT FROM THE PLACE WHERE IT WAS INSTALLED. ABSOLUTELY, KEEP THE MOONWALK UNIT AWAY FROM SWIMMING POOLS, WIRES.

5. SPECIAL INSTRUCTIONS: Moonwalk(s) equipment is reliable, however, should the Moonwalk(s) begin to deflate. First: Remove everyone from the moonwalk(s): (1) the motor has stopped; in which case check the cord connection at the outlet near the motor and remember to keep only the 100 foot extension cord on the outlet. [Stronger outlets are in the kitchen and laundry rooms] (2) If the motor is continuing to run, check the air intake on the side of the motor for blockage and check both tubes at the back of the moonwalk(s) for snugness; retie if necessary. (3) If you cannot correct the problem call OUR NUMBER 712-328-4316.

6. SAFE OPERATION ACKNOWLEDGMENT: LESSEE (customer) ACKNOWLEDGES THAT HE/SHE HAS BEEN INSTRUCTED ABOUT AND FULLY UNDERSTANDS, THE SAFE OPERATION OF THE MOONWALK(S) &/OR EQUIPMENT(S) THAT IS THE SUBJECT OF THIS RENTAL AGREEMENT & LESSEE AGREES TO OBSERVE ALL SAFETY PRECAUTIONS. LESSEE AGREES TO PAY LESSOR, ON RETURN OF THE MOONWALK(S) &/OR EQUIPMENT(S) FOR ALL CHANGES INCIDENTAL, TO BREAKAGE OR DAMAGE, ORDINARY WEAR EXCEPTED TO THE MOONWALK(S) &/OR EQUIPMENT DURING THE TERM OF THIS RENTAL AGREEMENT. BY INITIALING TO THE LEFT, THE LESSEE AGREES TO THIS PROVISION.

7. MAINTENANCE: Lessee agrees to keep the Moonwalk(s) &/or Equipment(s) in the same condition as when received, ordinary wear excepted.

8. ALTERATIONS AND ATTACHMENTS: No alterations in or attachments to the Moonwalk(s) &/or Equipment unit will be made without prior written approval of MJ Moonwalks & Party Rental.

9. WARRANTY: MJ Moonwalk & Party Rental warrants that the moonwalk(s) &/or Equipment(s) leased under this Rental Agreement will be in good working order on the effective date of the Rental Agreement. The Moonwalk(s) &/or Equipment(s) is supplied and maintained subject to this warranty. Lessor's obligation under this rental Agreement is limited to repair or replacement of the Moonwalk(s) &/or Equipment(s) when Lessor determines that it does not conform to this warranty. This warranty is in lieu of any and all other warranties expressed or implied, and of any and all obligations and of any and all liabilities on the part of the Lessor for damages, including, but not limited to, consequential damages, arising out of or in connection with the use or performance of the Moonwalk(s) unit.

10. TITLE TO MOONWALK(S) &/OR EQUIPMENT(S) UNIT: Lessee agrees to keep the Moonwalk(s) &/or Equipment(s) unit in he/she custody and not to sublease, rent, sell, remove from the Delivery Address, or otherwise transfer such Moonwalk(s) &/or Equipment unit. The Moonwalk(s) &/or Equipment unit will remain the property of the Lessor and may be removed by Lessor at any time after the termination of this Rental Agreement. BY INITIALING TO THE LEFT, THE LESSEE AGREES TO THE PROVISION.

11. RELEASE OF LIABILITY: The Lessee shall be in charge of the Moonwalk(s) &/or Equipment(s) operation, and is fully responsible for its operation as well as return of the Moonwalk(s) &/or Equipment(s) in good working order. Lessor and its officers, employees and agents is/are not responsible for injury occurring to the lessee or to any other persons using the Moonwalk(s) &/or Equipment(s) and the Lessee further agrees to hold the lessor and its officers, employees and agents free and harmless against any injury or claims. The lessee shall indemnify the lessor and its officers, employees and agents from/against any costs incurred due to claims from anyone and the attorneys fees and related costs involving the use and return of the Moonwalk(s) &/or Equipment(s) should legal action become necessary. BY INITIALING TO THE LEFT, THE LESSEE AGREES TO THIS PROVISION.

12. CANCELLATION POLICY: Cancellation with a two weeks notice for full refund. If less than two weeks, there will be no refund but you may reschedule up to 360 days with an extra reschedule fee of \$25.00 BY INITIALING TO THE LEFT, THE LESSEE AGREES TO THIS PROVISION.

13. ENTIRE AGREEMENT: This agreement constitutes the full agreement between lessor and Lessee. Time is of the essence of this Rental Agreement. The receipt of the Moonwalk(s) &/or Equipment(s) that is the subject of this Rental Agreement in good working order and repair is acknowledged by Lessee.
